Fund Objective

The Commodity Trends Strategy Fund seeks daily investment results, before fees and expenses, of the performance of the Standard and Poor's Commodity Trends Indicator ("S&P CTI™").

Target Index

Standard & Poor's Commodity Trends Indicator (S&P CTI) is an investible long/short strategy that offers exposure to 16 commodity markets (in six sectors) and will hold them long or short, based on a seven month exponentially weighted moving average. The long/short decision involves monitoring the price of the sectors in relation to their respective seven-month moving average price. The exception within the model is the Energy sector which, due to geopolitical issues, economic changes and other factors uniquely related to the sector, is positioned either long or neutral (flat).

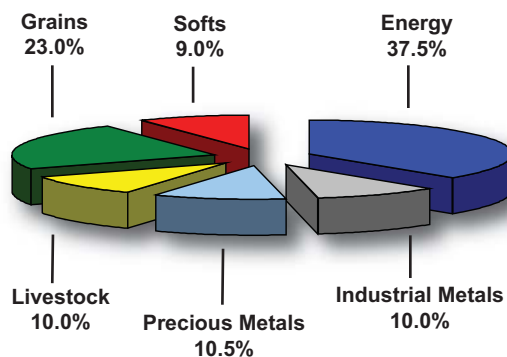
